Position Summary

The primary focus of this position involves delivering plant and hardscaping material to customers. Dispatch duties may include scheduling and routing product deliveries to customers. This position will also include working with the Operations Supervisor in pre-staging, prepping, and pulling materials scheduled for delivery. The Delivery Driver will ensure equipment is operating efficiently and all safety protocols are being implemented. The position involves standard customer service and requires experience with operating equipment. Must be able to work in a fast-paced environment that consists of both indoor office work and outdoor yard work. This is a full-time but seasonal position during the months of March – November.

Essential Duties and Responsibilities

The essential functions include, but are not limited to the following:

- Scheduling and routing product deliveries
- Contacting customers to arrange deliveries and keeping customers informed of delivery status
 Assign payment processing or other duties to the Office Assistant as needed
- Making sure trucks are loaded properly and that all loads fall within standard weight limits for each vehicle
- Assessing job site delivery requirements and assigning appropriate delivery vehicles
- Delivering product and material to customers
- Coordinating fleet maintenance and ensuring all repairs are completed properly and up to safety standards
- Coordinating with the Operations Supervisor and/or Equipment Operators to pull & pre-stage deliveries
- Ensuring that all OSHA and federal and state road procedures are followed
- Additional responsibilities may be added by the Hardgoods Manager as needed.

Physical Demands and Work Environment

This position involves working outdoors in all elements and indoors in an office setting. Can involve bending over, continual movement, being on your feet for many hours at a time and sitting in machinery. It is a dusty environment with frequent noise from machinery, radios, and telephones. There will be lifting and loading of bagged goods up to 50lb. at a time. Safety equipment is mandatory and provided. Prolonged periods of sitting and working on a computer required in office portion of position. It is a busy and dynamic environment through the Summer. While you are expected to work independently on various nursery projects, you are still expected to be readily available to all customers and staff members needing assistance.
